Privacy policy

1. Saved data

When a member joins, TSV Schönaich 1905 e.V. records the data mentioned above, including mandatory fields (*). This information is stored in the EDP systems of the cashier and the secretary as well as in the association's own Internet-based EDP system. Appropriate technical and organizational measures are taken to protect personal data from third-party access.

Other information about members and information about non-members is only processed or used by the association if it is useful for promoting the purpose of the association (e.g. storing the telephone and fax numbers of individual members) and there are no indications that the person concerned has a legitimate interest, which opposes the processing or use.

I agree with the storage, transmission, processing and use of my personal data for club purposes and goals as well as for information about special offers in accordance with the provisions of Art. 6 Para. 1 General Data Protection Regulation (GDPR). The data of the members are stored electronically.

I hereby agree that photos and films can be taken during training, when participating in competitions or during other club activities. To allow the association to publish on the association's own website or in the press, I waive my right to my own picture for myself or my underage child. This consent may be revoked at any time.

2. Member list

Only members of the board and other members who perform a special function in the association that requires knowledge of certain member data are given a list of members with the required member data. To exercise the statutory rights, the Executive Board issues a list of members with the names and addresses of the members to the applicant against written assurance that the addresses will not be used for other purposes.

3. Data retention

When leaving, the member's stored data will be deleted from the member directory. Personal data of the resigning member, which relates to cash management, will be kept for up to ten years from the written confirmation of the resignation by the board in accordance with the tax law provisions.

Contribution regulations of TSV Schönaich 1905 e.V.

(Extract from statutes dated June 21, 2024)

4. Contributions and costs

4.1. All members of the association are obliged to pay a membership fee.

4.2. The membership fee is due at the beginning of each calendar year and is to be paid in one amount to the association. Administrative costs amounting to 1/20 of the due membership fee will be charged for contributions that have to be remembered, but at least €5.00.

4.3. When entering until 30.06. is the entire annual fee from 01.07. half the annual fee is payable.

4.4. Honorary members are exempt from paying membership fees upon request.

4.5. Members who are in social hardship or who are otherwise unable to pay the fee can be exempted from paying the fee as a whole or in part upon application by the board. The membership remains unaffected.

4.6. The membership fees are determined by the delegates' meeting, course fees, administration and admission costs by the association committee.

4.7. The departments are entitled to collect departmental fees. They must be approved by the Board of Directors. In this case, the department fee is to be paid in addition to the membership fee.

It is assumed that you give the association direct debit authorization for the collection of contributions. Collection is due at the beginning of each calendar year. If you cannot decide to do so, we are forced to charge €5.00 per year for the additional work. The collection of departmental contributions is possible. Departmental dues are set and collected by the respective departments.
